

TWO-MINUTE SELF-TEST TO FIND OUT:

# Is There Going to Be a Legal Battle When I Die?

The following self-test is based on the experiences of the author and is intended as a humorous, but somewhat realistic, assessment of the “warning signs” that a family fight may erupt when you pass.

To take the test, just answer the following questions and add or deduct points for those that apply to you.

### Part A: My Family Makeup

I am single and I have only one child. I plan to leave everything outright to that child. *Add 20 points.*

I am single and I have 2-4 children. *Add 5 points.*

I am single and I have five or more children. *Add 10 points.*

At least three of my children are daughters. *Add 5 points.*

I am single and have no children. *Add 10 points.*

I am single and have children, but am leaving some or all of my estate to someone or something other than my children.

*Add 20 points.*

I am married, my spouse has children that are not my children, or I have children that are not my spouse’s children.

*Add 15 points.*

I am married and am leaving everything to my spouse, who is not the parent of my children. *Add 20 points.*

I have more than one child, and am not dividing my estate equally between them. *Add 20 points.*

### Part B: Me and My Family Dynamics

During some or all of my life I have been a difficult person. *Add 5 points.*

As a spouse, partner or parent, I have been too controlling and too critical of the people closest to me. *Add 10 points.*

Some of my children are estranged from me. *Add 15 points.*

Our family dynamics are best described as:

- (a) Completely dysfunctional *add 20 points.*
- (b) Moderately dysfunctional *add 10 points.*
- (c) Only a little dysfunctional *add 0 points.*
- (d) There are no issues in my family. (If you believe this is true you are delusional, please either reconsider your response or *add 30 points.*)

I was involved in litigation over my parents’ estate. *Add 10 points.*

I was involved in litigation over my parents’ estate and I thought it was fun. *Add 25 points.*

### Part C: Status of My Estate Plan
